Synopsis of Proposed Legislation Grand Lodge 2007

THEREFORE BE IT RESOLVED, that Chapter 46.1 1 be revised to allow the location of the Memorial Lodge Charter and the listed address to be changed from year to year by the newly elected Worshipful Master. Provided that the location must be that of one of the supporting Lodges within the same District as the Memorial Lodge, and that this location will be included with the required Annual Returns as submitted to the Grand Secretary, and that this address will be the address listed in any of the Grand Lodge booklets for the ensuing year.

Jurisprudence: Approved GL: **APPROVED**

THEREFORE BE IT RESOLVED, the second or last sentence as show above of said paragraph be deleted and removed. "Residents shall agree to perform such reasonable labor in and about the Home and grounds as they may be requested to do so by the Administrator if physically able to perform such labor."

Jurisprudence: Approved GL: **APPROVED**

THEREFORE BE IT RESOLVED, that the Grand Lodge of Florida will respect the will of Particular Lodges, arrived at by due process of the Particular Lodge, to prohibit or to allow Lodge members access to Lodge membership records of their own Lodges, as well as the method for such access.

Jurisprudence: Rejected GL: **REJECTED**

THEREFORE BE IT RESOLVED, that said budgets, be amended to also show the ACTUAL financial figures expended for the preceding year: in the proposed legislation booklet presented to the Craft at Grand Communications, include a column showing actual expenditures in all line-item categories of the previous year: (April 1st – March 31st)

Jurisprudence: Rejected GL: **REJECTED**

THEREFORE BE IT RESOLVED, that the lifetime title of "Right Honorable" be awarded to the District Instructors of our Grand Lodge, past, present, and future. The abbreviation of this title shall be R.:H.: , in the case of a Brother serving as District Instructor after he has served his District as District Deputy, the title of "Right Worshipful" would still be used and considered proper.

Jurisprudence: Approved GL: **APPROVED**

THEREFORE BE IT RESOLVED, That the requirement for a Brother to be eligible to be elected Master or Warden of his particular lodge be as follows:

1. The Brother must have returned a satisfactory proficiency in the E.A., F.C., and M.M. catechism.
2. The Brother must have completed the Lodge Officers Training Course.
3. The Brother must have completed the Master Mason Course Modules 1, 2 and 3.
4. The Brother must have attended at least one Warden's Workshop.

Jurisprudence: Rejected GL: **REJECTED**

THEREFORE BE IT RESOLVED, that Particular Lodges of the Grand Lodge of Florida shall be entitled to conduct stated communications in the Entered Apprentice degree should the Lodge determine to do so. However, based experience and time in the Fraternity, only Master Masons can vote on transacted business before the Lodge, including, but not limited to; Lodge elections, Masonic trials, Masonic funerals and any other business, work and instruction specifically noticed by the Worshipful Master to be performed in the Fellow Craft or Master Mason degree and any degree work of a subsequent degree a Brother to the Fraternity has not yet been initiated into.

Jurisprudence: Rejected GL: **REJECTED**

THEREFORE BE IT RESOLVED, that in the best interest of the Craft and the Brethren of Zone 3, that the duplicate copy of the "Forms and Ceremonies" now housed at Grand Lodge in Jacksonville, Florida be relocated to Orange Park Lodge No. 267 in Orange Park, Florida.

Jurisprudence: Approved GL: **APPROVED**

NOW, BE IT RESOLVED, that all candidates be required to undergo a criminal background investigation from one of three entities as may from time to time be approved by the Grand Lodge at the expense of the candidate

Jurisprudence: Approved GL: **REJECTED**

THEREFORE BE IT RESOLVED, that in paragraphs 7.04 (a) and (b) on pages 366a and 367 of the Appendix of our Digest of Masonic Law, "thirty-three and one third percent (33 1/3%) of his entire estate be changed to \$10,000". The fifth and sixth lines would then read: "donate, transfer, or by any other means or device, convey up to but not to exceed \$10,000 to a Particular Lodge"

Jurisprudence: Approved GL: **REJECTED**
